Eligibility checklist

- ☐ Eligible nationality for visa on arrival
- ☐ Passport valid for at least 6 months
- ☐ Return or onward ticket
- ☐ Arrival at a designated entry point

DOCUMENTS TO PREPARE

Complete checklist

REQUIRED FOR EVERY APPLICANT

- ☐ **Passport scan**
Valid for at least 6 months from arrival, colour scan of the bio page.
- ☐ **Return or onward ticket**
Booking showing you will leave within the permitted stay.
- ☐ **Accommodation proof**
Hotel or villa booking, or host address details.
- ☐ **Digital photograph**
Recent photo for the electronic application.

SUPPORTING DOCUMENTS

- ☐ **Proof of funds**
Bank statement or card evidence supporting the length of your stay.
- ☐ **Customs declaration**
Electronic customs declaration completed before arrival.
- ☐ **Health or tourist levy**
Bali tourist levy receipt where applicable.

PURPOSE-SPECIFIC DOCUMENTS

- ☐ **Tourism (e-VOA)**
Passport scan, ticket and accommodation are usually sufficient.
- ☐ **Business visit**
Invitation letter from the Indonesian company and employer letter.
- ☐ **Longer stays**
A tourist visa applied in advance suits trips beyond the VOA limits.

01

Eligibility check

We confirm your nationality and entry point qualify.

02

Application

e-VOA filed before departure with your travel details.

03

Approval

Your electronic approval is emailed before you fly.

04

Arrival guidance

What to show at immigration and the customs declaration step.

Important to know

- The e-VOA can be extended once for another 30 days without leaving the country.
- Arrival must be at an airport or seaport approved for visa on arrival.
- The Bali tourist levy is separate from the visa and is paid online.
